In accordance with Nebraska State Soccer's Constitution and Bylaws, this form must be signed by the President or Secretary of your association, league or club and received by Nebraska State Soccer's Secretary no later than ten (10) days prior to the AGM. We would like the form by November 6, 2009. **Credentials can be turned in late, but will be subjected to approval from the floor at the AGM.**

You must designate your individual representative or an alternate if no one from your association, league or club can attend. No other individuals will be allowed to vote. In addition, your association, league or club must be in good standing (e.g., all fees fully paid) in order to vote. In early October, statements went out to all the affiliate members. Check with your contact, get with your Treasurer and send the check to the State Office. We want you to be a part of the event. Voting rights at the Annual Meeting for Association issues, elections or at the District Meetings shall be as follows: Each member of the Board of Directors shall have one vote. Each Affiliate Member in good standing affiliated with this Association shall have one vote. Each Affiliate Member shall also have one additional vote for every 100 players or part thereof, based on registered teams during the current fall season. Voting rights of the referee representative shall be based upon one vote and one additional vote for each 100 duly and properly registered USSF referees. The SRA shall be the referee representative for voting purposes. Each league or association affiliated with this Association shall have one vote.
